**GENERAL TERMS & CONDITION**

**Delivery & Transportation:**

- 1) Lead time of 30 days will be taken to execute the goods after receiving the P.O. in written at our place, time also depends upon the nature, quantum & availability of supplies of material and order placed.
- 2) **Transportation and Handling Cost & Insurance Cost (If any) of delivering the goods from the factory premises to the buyer is to be borne by the buyer. Prices are Ex-Indore, else otherwise specified.**
- 3) Company ceases its liability as soon as goods leave its premises and shall not be responsible for any loss & time taken during transit.
- 4) Any sort of additional packaging required by the client shall be charged extra.

**Placing Order:**

- 5) Order shall be construed only after receiving a valid P.O. duly acknowledged by competitive authority mentioning the exact details regarding the goods required and also mentioning the acceptance of the terms & condition laid hereby without any altering effect.
- 6) After receiving the P.O.; if needs arise to cancel then the buyer shall have to borne all the losses & expenses occurred in effect to this P.O.
- 7) Details conveyed through P.O. regarding the product shall stand final and any deviation will not be entertained for that P.O.
- 8) Quotation prices shall be valid for 15 days only from the date of placing Quotation, after wards if order has been placed, quotation may tend to revise upon company' s discretion.
